### **What information does Nithyananda Hindu University collect?**

Nithyananda Hindu University collects the Personal information only from persons who contact us and voluntarily provide the information to us or that is given to us by various affiliated Nithyananda Hindu University organizations (satsangs and centers) and co-organizers that have your permission to share your Personal information. \*Personal information\* means your name, shipping/ mailing address, telephone number, fax number, and email address and may include your program registration and donation preferences. We do not collect credit or debit card account numbers through our website.

### **How Nithyananda Hindu University uses the Personal Information**

1. We use your personal information to respond to process online payments and fulfill requests for products and services including: Sending information about the activities, classes and programs of Nithyananda Hindu University and/or its third party affiliates.
2. Sending you our e-newsletters, promotional offers about our products and services.
3. Contacting you about the status of your orders, donations and program registrations
4. Completing your purchases and program registrations
5. Completing your donations

### **When we disclose personal information to others**

1. Nithyananda Hindu University does exchange Personal information with various affiliated organizations in the U.S. and abroad so that they can contact people on the mailing list about Nithyananda Hindu University's programs and events and/or enrich them about other relevant



upcoming programs and events in line with the charitable activities and vision of Nithyananda Hindu University.

2. We use personal information to send promotional offers about our services, offerings and programs.
3. Nithyananda Hindu University's mailing list, including the Personal information we receive through the internet, is never shared with any commercial organizations and is never sold, rented or given to unrelated third parties.
4. Nithyananda Hindu University will disclose Personal information to third parties if we believe in good faith that the law requires us to do so.

### **Right to control and procedures to protect personal information**

1. Individuals who wish to register online for our programs and events are allowed to register online using the Register pages/links and/or via a third party teaching platform available via our website by providing their name, address, email id, and telephone number.
2. Nithyananda Hindu University limits access to your Personal information to those persons that are required to fulfill the requests for information, services or products. Your Personal information is protected with access only to those selected and authorized persons.

### **Regarding Children**
